DAYCARE, GROOMING & BOARDING AGREEMENT

Client Agreement and Release of Liability

I hereby release the Arlington Dog House, LLC hereafter referred to as ADH, its agents, officers, sub-contractors, employees, animal owners, customers, and potential customers of ADH from any and all liabilities, financial, and otherwise, for injuries to myself, my dog, or any other property of mine, which arise in any way from services and/or products provided by, or as a consequence of my association with ADH.

I agree to assume all liabilities and responsibilities, financial and otherwise, for the behavior and health of my dog. In consideration of the services rendered by ADH, I waive any and all claims, actions, or demands of any nature, foreseen or unforeseen, that I may have against ADH relating to the care, control, health, and/or safety of my dog arising during pick-up, transport, drop-off, and stay at their facilities.

Further, I agree to indemnify, hold harmless, and defend ADH from and against all losses, claims, damages, liabilities, costs, attorney's fees and any other expense of every nature whatsoever incurred by and asserted against ADH by any third party due to any damage, injury or death caused by my dog. I authorize ADH to do whatever they deem necessary for the safety, health, and wellbeing of my dog while under the care of ADH, including seeking professional veterinary treatment for my dog.

Due to the many outstanding benefits of dog socialization and ADH's commitment to the safety and wellbeing of my dog, I agree that the benefits of dog socialization outweigh the risks. Furthermore, I request a socialized environment for my dog while under the care of the staff of ADH.

I understand that my dogs' immunizations must be kept current and that failure to provide evidence of their currency is basis for refusal of my dogs' participation until they are current and updated records have been provided to ADH. I further understand that ADH staff temperament tests all dogs prior to admission to daycare and boarding to ensure the safety of each dog in their care. In the unlikely event my dog does not pass this test they will be prohibited from participating in any off-leash events at ADH as well as prohibited from participating in the daycare and boarding services provided by ADH until they have been re-tested and pass. ADH has the right to refuse service to me and/or my dog at any time for any reason. I understand that if my dog has a history of or repeatedly demonstrates aggression or biting of humans or animals, ADH reserves the right to refuse service.

Both ADH and the Dog's Owner(s) agree that the laws of the State of Illinois shall govern this Agreement, the construction of its terms and the interpretation of the rights and duties of the parties hereto.

Both parties also agree that if any provision of this Agreement, or any portion thereof, is found to be invalid or unenforceable, the remainder of this Agreement shall nevertheless remain in full force and effect. Under no circumstances shall ADH's liability hereunder be greater than the sum paid to ADH for the care of my dog(s).

This Agreement and any documents or exhibits attached hereto constitute the entire understanding and agreement of the parties, and any and all prior agreements, understandings, and representation are terminated and cancelled in their entirety and are no force and effect. No amendment, change or modification of this Agreement shall be valid unless in writing and signed by the parties hereto.

Hours of Operation, Boarding and Daycare Pick-up Requirements

I understand that the hours of operation of the Arlington Dog House are 6:30am to 7pm Monday through Friday, 8am to 3pm Saturday and that Sundays from 9am to 10am and again from 3pm to 4pm and are only for boarding pick-up and drop-off. A \$1/minute late fee applies both after 7pm until 7:30pm during the week and from 3pm to 3:30pm on Saturday, after which time my dog becomes an overnight guest at ADH and will be boarded at my expense. Should this take place, I authorize in advance that ADH will automatically begin charging me for these services and that they will be paid in full when I, or my agent, picks up my dog.

Boarding is a 24-hour reservation-based service and dogs not picked up within their reservation time are subject to a \$1/minute late fee for the first 30 minutes and, if still in the care of ADH, will be automatically boarded for an additional 24 hours at the owners expense.

I hereby declare to ADH that I am the legal owner of my dog; that my dog has not been exposed to distemper, rabies, or parvovirus within the past thirty (30) days that my dog has been inoculated as indicated by records which have been presented to ADH.

By signing below, I acknowledge that I have read this Daycare, Grooming and Boarding Agreement in its entirety and agree to the terms.
